The Board of Directors of FOCOL Holdings Limited (FOCOL) is pleased to present the unaudited results for the first quarter ended October 31, 2018. Net income for the three months ended October 31, 2018 was \$6.6 million compared to \$6.1 million for the same period in the previous year.

During the first quarter of fiscal 2019, Management completed the installation of a new industry-specific software. The Company is starting to realize the benefits from the new software.

On August 31, 2018, the Company successfully purchased an ocean-going propane ship that will allow us to purchase propane directly from our supplier in the U.S. Gulf. This acquisition will significantly increase our capacity to grow our propane business in The Bahamas and The Turks & Caicos Islands while improving security of propane supply for our customers.

The Board of Directors wishes to thank our loyal customers, dedicated staff and shareholders for their continued confidence in FOCOL Holdings Limited.
