The funds were the proceeds from the sale of Brain Cancer Awareness wristbands. Reg passed away 4 February 2019 after a 2-year battle with Glioblastoma Multiforme (GBM), an aggressive form of Brain Cancer. Mr. Grant is the father of BISX COO, Holland Grant.

The Grant Family plans on selling Brain Cancer Awareness wristbands every year around Reg's birthday. Elizabeth Grant noted: "We started small this year with 300 bands because we were not sure of the demand but each year our goal is to sell more bands to help the Staff and Patients at the Oncology Centre as they battle this dreaded disease. I encourage other families that lose a loved one to find avenues such as this to give back as a tribute to their loved one."

BANK OF THE BAHAMAS AGM HIGHLIGHTS

In Fiscal 2019 Bank of The Bahamas' net income increased to \$2.9 million from \$1.6 million in the prior year according to Jihanne Hosmillo-Williams, Chief Financial Officer, Bank of The Bahamas Limited. Providing financial highlights at the Bank's Annual General Meeting on November 22, 2019, Mrs. Hosmillo-Williams said the Bank continued on a profitable track in Fiscal 2020 with a net income of \$487,000 for the first quarter ended September 30, 2019. This was achieved despite increased credit loss expenses that were due in part to the impact of Hurricane Dorian on the Freeport loan portfolio and in part to the implementation of International Financial Reporting Standards 9 (IFRS9).

Mrs. Hosmillo-Williams said the Bank continues to show strength and stability in its capital ratios and liquidity. "CET1 ratio is now more than four times the minimum requirement of 9.6% at 41.1%. As at first quarter 2020 our liquid asset ratio of 217% has more than doubled the minimum requirement. With a strong capital ratio and strong liquidity ratio we are well positioned for growth," she said.

Managing Director Kenrick Brathwaite also addressed shareholders and talked about initiatives the bank is taking to sustain profitability and become more efficient and customer focused. "We are well on our way to achieving the things necessary for strengthening our foundation...once we strengthen the foundation accelerated growth will come very easily for us, Mr. Brathwaite said. "My vision is to ensure that BOB becomes the most efficient, customer centric bank in The Bahamas", Mr. Brathwaite said. Towards this goal he said the Bank has also introduced a Customer Experience Unit to address complaints and ensure that a culture of customer service excellence exists.

"He revealed that a number of significant projects are in progress at the Bank including the upgrade of the core banking system and the introduction of a loan origination platform which is expected to fully automate all loan processes. Additionally, he said the Bank has restructured its organization to enable maximum efficiency, once loan processes are automated.

INVESTING TERM


